**364. Hanging Baskets**

The Clerk advised Members that Carmarthen BID had agreed to fund 220 hanging baskets, additional tiered planters and cover the cost of employing a third party to water the baskets and planters within the BID area for 2024. They would also arrange to water baskets outside the BID area, the cost of which would be covered by the Town Council.

The Chair, Cllr. Peter Hughes Griffiths noted his support for the community partnership working and was grateful for the benefits it brought to the community.

Members **RECOMMENDED** that Council should support the partnership.

**365. Martyn's Law – Standard Tier Consultation**

The Clerk explained the background to the Home Office consultation on the new Terrorism (Protection of Premises) Bill. This legislation would impact all premises with a capacity of 100+ people with an enhanced tier for premises of 800+ capacity. A discussion was held, and members **NOTED** the consultation. The Clerk will update members as the bill progresses through parliament and the requirements of the legislation are finalised.

**366. Parc Hinds Wall**

The Clerk advised Members that meetings with Cadw and the Heritage Officer from Carmarthenshire County Council had taken place following a further collapse of the wall at Parc Hinds. Responsibility funding for the work was discussed and it was **AGREED** that the safety of the wall and people in the park would be prioritised with discussions regarding ownership and responsibility to follow with Carmarthenshire County Council.
